



Reproduction of Material Supplied by Chesham Museum Terms and Conditions

If you wish to reproduce photographs, video, audio recordings or other material held by Chesham Museum you must agree to comply with these terms and conditions.

General Conditions

1. All communication connected with the reproduction of material held by Chesham Museum should be addressed to the Curator.
2. Requests are considered only on receipt of a completed 'Application to Reproduce Material Held by Chesham Museum' form. If accepted, a copy of the authorised form will be returned to the applicant.
3. No further copies or use may be made of material supplied to the applicant by Chesham Museum except solely for the purposes originally declared in the application. They may not be reused without permission, or supplied to any other person or organisation.
4. Chesham Museum reserves the right to refuse an application without explanation.
5. Material which has been loaned to the applicant remains the property of Chesham Museum and must be returned by the date specified or as soon as it is no longer required for the purposes originally declared in the application. A fee will be charged for late return.
6. In the case of the loan of original material, this may not be copied for any other purpose than that originally declared. In the case of film, video or audio recordings extracts may be selected from the loaned material but such extracts must be used in their entirety without further editing. There must be no modification, distortion or addition of any new material to such extracts.
7. On the publication, broadcast or release date a complementary copy of each publication, broadcast or product must be forwarded to Chesham Museum for record purposes.

Acknowledgements

1. With the exception of reproductions used in advertising, the following acknowledgement must appear either next to the reproduction or in the section devoted to acknowledgements: **'By permission of Chesham Museum'**.
2. In the case of television programmes, films and videos, acknowledgement to Chesham Museum must be included in the credits.
3. Where reproductions are used for advertising or promotional purposes the form of acknowledgement must be approved by the Curator.

Charges

1. Fees charged can be found in our list of fees and charges.
2. Fees and charges are payable with order. An invoice will only be issued on request and must be paid within 30 days.
3. Charges payable cover only the specific occasion detailed on the application form. All reprints, further editions or re-use of the material require a new application and are not covered by the original payment.

Copyright clearance

1. Chesham Museum does not hold records of the copyright ownership for some items in its collections. Therefore Chesham Museum may not be the owner of all the rights in the material supplied. Chesham Museum does not authorise photography, filming, reproduction, internet publishing or broadcast under any rights it does not own. The applicant must ensure that all necessary rights and consents to publish or broadcast are properly cleared in advance at the applicant's expense.
2. Chesham Museum shall have no liability however arising from any photography, filming, reproduction, broadcast or publishing (including internet publishing or broadcast) of any Chesham Museum material by the applicant or any other person. The applicant shall indemnify Chesham Museum against all claims, demands, proceedings, costs, charges and expenses arising from such activities.
3. Any fee payable to the copyright holder is additional to the fee due to Chesham Museum.

Photography, Filming, Video and Sound Recording

1. Applicants who wish to photograph, film, video or make an audio record of material held by Chesham Museum will be bound by these terms and conditions. In particular, applicants should note the section on copyright clearance. In addition, anyone carrying out the photography, filming or recording will be required to sign a form accepting full responsibility for any injury to persons or damage to property incurred while using the facilities.
2. Facility fees may be charged at the discretion of the Trustees of Chesham Museum for photography, filming, video or audio recording on Chesham Museum premises.
3. The applicant or photographer as appropriate shall, on request, assign to Chesham Museum copyright in all images made of material held by Chesham Museum.
